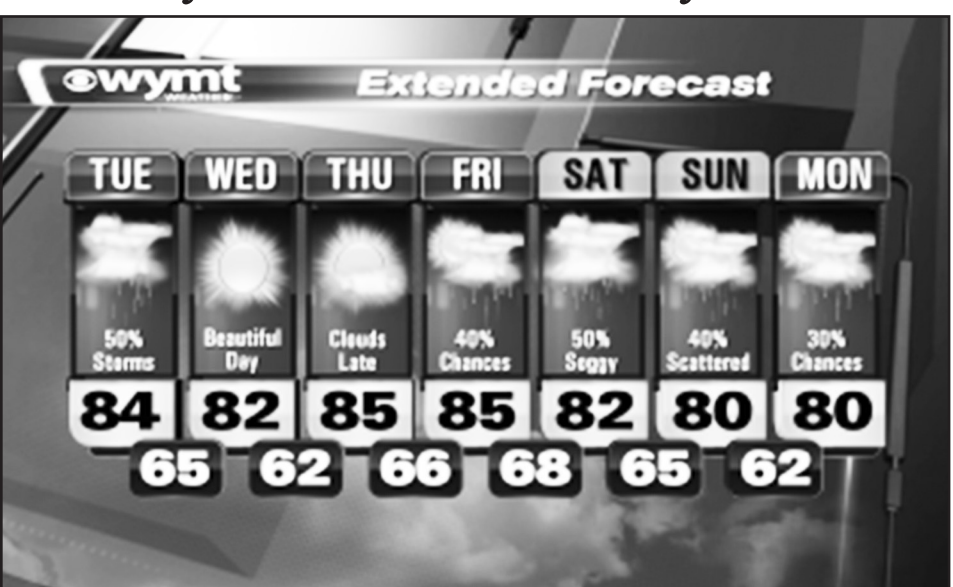

District Court News

Judge Hon. Allen B. Roberts 07-16-18

Carpenter, Brently-Driving on DUI suspended license-1st offense-Amended to No license in possession; Failure to comply w/helmet law >21 yrs.; Motorcycle registration plate; Unapproved/No eye protective device (motorcycle); Regs for operating and riding on motorcycles; No motorcycle operators license; No/Expired registration plates; Failure of owner to maintain required insurance/security

Cole, Tommy Jack-Assault 4th degree minor injury. To have atty. Hon. S. K. Allen for def. Continue by agreement. Set pretrial conference 8-13-2018.

Durham, David L-No/Expired registration plates; No/Expired Kentucky registration receipt; Failure of owner to maintain required insurance/security 1st; Failure to produce insurance card; Operating on suspended/revoked operators license; Failure to register transfer of motor vehicle. Counts 1-6: Not guilty plea. Pretrial Conference 9-24-2018. Appt DPA.

Estep, Nancy Marie-Failure to produce insurance card; Failure of owner to maintain required insurance/security 1st. Counts 4 & 5: Dismissed with proof. Court notice mailed on 5-22-18.

Farra, Rodney Dale-No/Expired registration plates; Failure to produce insurance card. Counts 1 & 2: Dismissed. Proof reg & insur. filed.

Fowler, Patricia A-Op mv under/influence of alcohol/drugs, etc. .08 1st off; Failure to wear seat belts; Operating on

suspended/revoked operators license; Possessing license when privileges are revoked/sus; Failure to appear, Citation for misdemeanor. WOA served for FTA at pretrial. (arrested in Madison Co.: Clerk has not received bail bond). Issue WOA. \$500 cash bond. Bond forfeiture hearing 8-13-2018.
