


# WYMT News

### District Court News

**Judge Hon. Allen B. Roberts 10-15-18**

Goodman, Anna-Resisting arrest; Disorderly conduct, 2nd degree; Public intoxication controlled subs (excludes alc). Counts 1-3: Not guilty plea. Appoint DPA. Pretrial conference 11-05-2018.

Hall, Ralph Jr-Assault, 1st degree. Not guilty plea. Appoint DPA. Preliminary hearing 10-29-2018.

Isaacs, Billy R-Failure to wear seat belts; Operating on suspended/revoked operators license. Counts 1 & 2: Dismissed without prejudice with warning. Has active WOA for FTA. Recall WOA.

Kerby, William D-Resident fishing without a license/permit-Dismissed with proof; Failure to appear, citation for misdemeanor-Dismissed without prejudice. WOA served for FTA at arraignment; Filled \$500.00 cash bond for today. Release bond.

Johnson, Jackie Paul-Failure of non-owner operator to maintain req insurance, 1st; Operating on suspended/revoked operators license. Issue WOA; \$250 cash bond.

Judd, Ashley N-Assault 4th degree domestic violence minor injury. Schedule Court Trial 11-19-2018.

Kerby, William D-Bond Forfeiture Hearing; Cause shown.

Kerby, William D-Failure to wear seat belts-Dismissed with warning; Operating on suspended/revoked operators license-Dismissed with proof; Failure to surrender revoked operators license-Dismissed with proof.

then 11/2 at 8:00 pm to 11/3 at 8:00 pm, \$350 fine and \$375 service fee and court costs, Suspend license 12 months, Order to attend and complete DUI school, FRD 12-17-2018. Ops. lic. are pretrial suspended.

Weaver, Jerry L-Improper/No windshield; No/Expired registration plates; No/Expired Kentucky registration receipt; Failure of owner to maintain required insurance/security 1st; Improper display of registration plates; Failure to register transfer of motor vehicle. Counts 1-6: Not guilty plea. Pretrial conference 2-25-2019.

Winningham, Tim Dewayne-Operate mv u/influ of alc/drugs w/.08, Aggravator, 1st off-Guilty plea, 5 days jail, CTS 5 days, \$375 service fee and court costs, Suspend license 90 days, Order to attend & complete DUI school, FRD 12-17-2018; Giving officer false identifying information-Guilty plea, 5 days jail, CTS 5 days; No operators/moped license-Dismiss; Failure to produce insurance card-Dismissed.

Zoumana, Simpapa-No/Expired Kentucky registration receipt; No/Expired registration plates; Improper passing; Careless driving. Continue to 11-05-2018.
