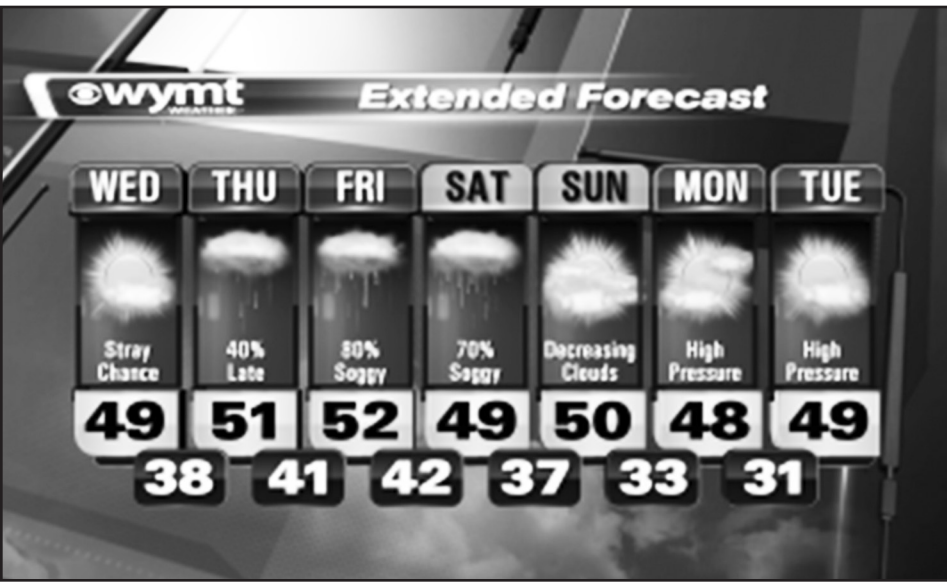


# WYMT News

### District Court News

Judge Hon. Henria Bailey-Lewis 12-10-18

Lawson, Carl Wayne-Promoting contraband-2nd degree. Guilty plea, Set to 90 days in jail, CTS 3 days, Conc. Court finds plea is ki&vol.

Richardson, John E-No/Expired registration plates; No/Expired Kentucky registration receipt; No operators/moped license; Operating on suspended/revoked operators license; Failure to appear, citation for misdemeanor. Counts 1-5: Guilty plea, Set to 5 days in jail, CTS 5 days and court costs, 3-04-2019.

Adams, James A-Already has a warrant from 11-20-18 for drug court violation.

Alisp, John-TBUT or disp shoplifting u/\$500. Dismissed with prejudice. Motion to dismiss by commonwealth-No objection by def.

Barger, Georgia-Failure to notify address change to dept of transp; No operators/moped license. Continue to 2-18-2019.

Has FTA/DOT. Def may be in jail in another county. Continue to 1-07-2019 to give County Attorney time to review.

Collins, Cody C-Resisting arrest; Public intoxication controlled subs (excludes alc); Disorderly conduct, 2nd degree; Menacing. Counts 1 & 4: Guilty plea, Set to 180 days, CTS 6 days, 174 CD for 2 years and court costs, 3-04-2019. Counts 2 & 3: Dismissed without prejudice by agreement. Court finds plea is ki&vol.

Couch, Rodney D-Speeding 26 mph over/greater; Reckless driving. Not guilty plea. Sent court notice. 2-18-2019.

Dixon, Heather-Cruelty to animals-2nd degree. Not guilty plea. Court finds def qualifies and appoints DPA. PTC: 1-07-2019.

Dixon, Jason Jay-No/Expired registration plates. Not guilty plea. Pretrial conference: 2-18-2019. See citation: Office changed name, court time and entered court date for arrest date on citation.

Def waives days on preliminary hearing; Continueto 1-07-2019 to see if assesses eligible for DC.

Harris, Deanna-Criminal possession forged instrument-2nd degree-I; Receiving stolen property u/\$500. Waived days. Continued by agreement to 2-04-2019.

Harris, Deanna-TBUTor disp shoplifting u/\$500. Continue by agreement 2-04-2019.

Horn, Gary A-No/Expired registration plates; No/Expired Kentucky registration receipt; Failure of owner to maintain required insurance/security 1st; Failure to produce insurance card; Improper display of registration plates. Counts 1-5: Dismissed without prejudice. Recall FTA.
