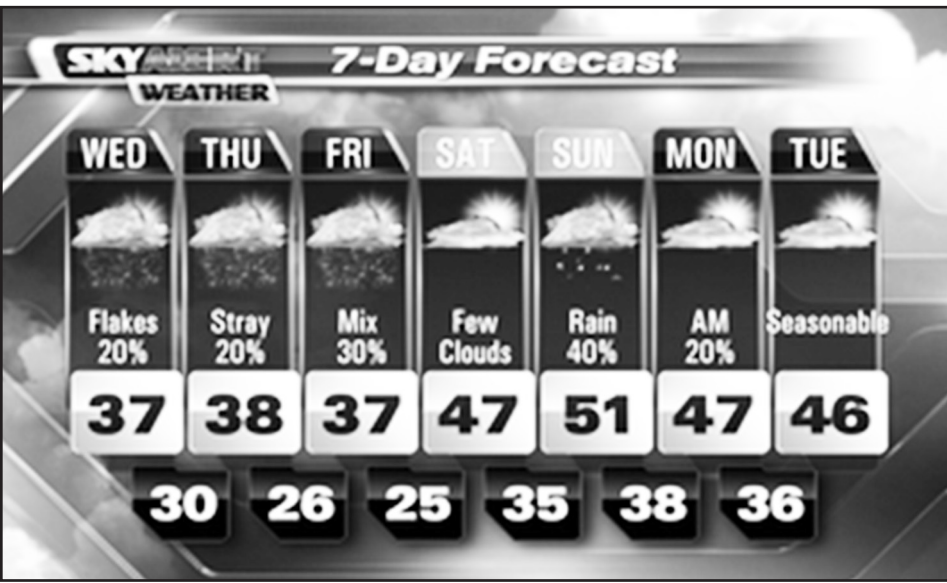


# WYMT News
