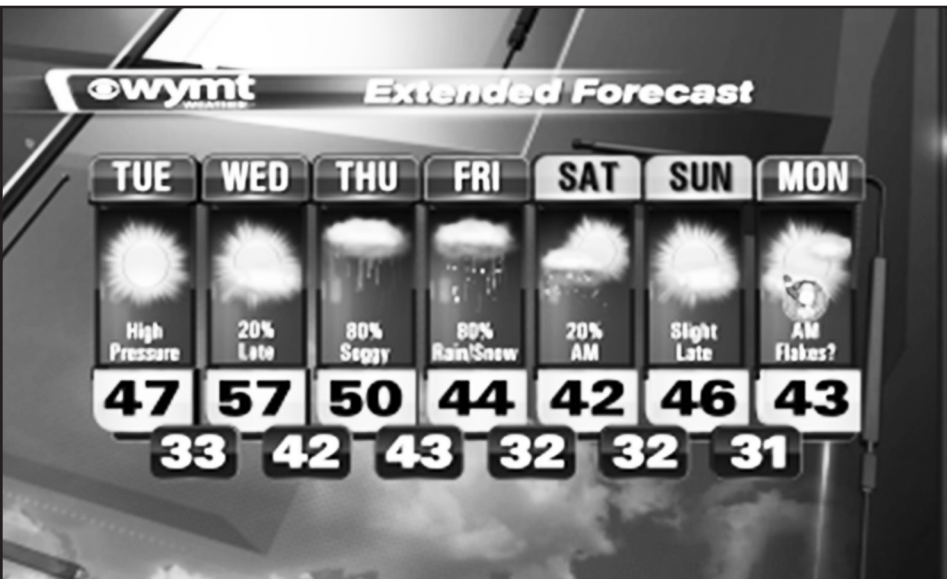

District Court News

Counts 1-6: Not guilty plea. Def waives days. Appoint DPA. Preliminary Hearing 1-02-2019.

Abner, Steven-Op mv under/influence of alcohol/drugs, etc. .08 1st off. Court Trial 1-14-2019.

Baker, Mary Ann-No/Expired registration plates-Dismissed; Operating on suspended/revoked operators license-Not guilty plea; Failure to notify address change to dept of transp-Not guilty plea; No/Expired Kentucky registration receipt-Dismissed; Failure of seller of vehicle to disclose title brand-Dismissed; License to be in possession-Not guilty plea. Pretrial Conference 3-11-2019.

Flannery, William T-Reckless driving; Operating on suspended/revoked operators license; No/Expired Kentucky registration receipt; Failure to

produce insurance card-Dismissed with proof; Failure to notify address change to dept of transp. Continue to Court Trial 5-06-2019.

Fowler, Clifton B-Failure to or improper signal; Disregarding stop sign; Failure to notify address change to dept of transp; No operators/moped license. Sent court notice. Continue to 1-28-2019.

Gabbard, Leslie-Local county ordinance. Sent court notice. Continue by agreement to 1-14-2019.

Counts 1-3, 6 & 7: Dismissed without prejudice. Has FTA-DOT; Def is state inmate (in Jackson Co Jail). Recall FTA.
